



How CAMS Works

CAMS reduces audit overhead by 25 percent by making the process easy and accurate. The solution offers full functionality on any device, so that the end user can choose the most convenient tool. In the following example, the auditor uses a laptop and mobile phone combination.

1. On her office laptop, the auditor uses CAMS to create an audit for a new format of store.
2. Onsite the audit manager uses the CAMS mobile app on her phone to select and complete the audit form. It has the same functionality as if she used a tablet or computer.
3. She takes several photos, records a short video, and quickly attaches them to the audit.
4. In the back corner of the warehouse, she does not get cell phone or Wi-Fi reception, but she continues to use the app. Later, when she is in range, the app synchronizes the data.
5. When she has completed the audit, she uses CAMS to create her final report, complete with easy-to-understand findings and action plans. The system automatically emails the report to the appropriate personnel.
6. The system automatically issues follow-up alerts to the store manager who updates his action plans as actions are completed.

Audits That Get Results

What good is an audit with sketchy information or a confusing action plan? The simple user interface and sophisticated inner workings of CAMS makes it easy to collect and use robust information. Using the results of the current audit and historic information, you can create clear action plans and present them in an attractive, easy-to-understand format.
